**\*This application must be accompanied with 2 sets of images of the proposed banner**

**\*Banners may not be placed on public property** (except for directional signage as approved by the City for an Event Signs with a map designating the location of the signs and they are not placed more than 8 hours prior to the event and removed no later than 4 hours after the event)

\*If the applicant is not the property owner a letter of approval from the property owner must be attached with the application.

\*No more than 5' in height and not to exceed 32 square ft. in sign area

**\*New Business Banner:** A new business may display one (1) temporary banner on nonresidential property for a period not to exceed ninety (90) days. **Fee \$50.00**

**\*Temporary Business Banner:** may be displayed with permit not to exceed 14 calendar days, 1 banner allowed from calendar quarter to calendar quarter. **Fee \$50.00**

**\*Event banner:** may be displayed on nonresidential property for a period not to exceed five (5) days in a calendar quarter, along with no more than 10 directional signage (with map provided). **Fee \$100.00**

**\*Non-Profit Banner:** is to be erected no more than five (5) days prior to the event being – Nonprofit banner fee is **\$10.00** non-refundable.

**Banners must be removed after the time allowance or the City of Fulshear will remove and discard the banner. City of Fulshear Blue tag must be on the banner or it may be removed and cited.**
