Any person may attend and provide comments. A copy of the proposed budget is on file with the City Secretary at the address shown and on the Fulshear website (www.fulsheartexas.gov).

This budget will raise more revenue from Property Taxes than last year's Budget by an amount of \$348,430 which is an increase of 19.8% from last year's Budget. The property tax revenue to be raised from new property added to the tax roll this year is \$225,334.




