Driving Safety Course Request: Citation Number: _____

You are eligible to take a driving safety course if:

- You have a valid Texas driver’s license that is **NOT a commercial driver’s license**;
- You can show proof of financial responsibility (insurance – YOU MUST BE A LISTED DRIVER ON THE POLICY);
- You have not requested and taken a driving safety course in order to have a ticket dismissed in the preceding 12 months from the date of this offense;
- The offense did not occur in a construction zone when worker’s were present;
- You were not speeding 25 mph or more over the legal speed limit;
- You were not operating a commercial motor vehicle; and
- You did not pass a school bus while children were loading/unloading.

You must make a written request to the court to complete DSC **BEFORE** you complete the driving safety course. To make your written request to complete a driving safety course, you must mail (post-marked on or before court date) or bring the following (on or before court date) to the court:

- A plea of GUILTY or NO CONTEST by checking the appropriate box above;
- A copy of your driver’s license;
- A copy of your current insurance card;
- The affidavit below (must be signed and **notarized**); and
- A money order, cashier’s check or personal check in the amount of **\$129.00** (\$154.00 if violation occurred within a school zone).

The court will mail you a notice of your completion date. An application for a certified copy of your driving record can be found in our website under **SERVICES: COURT FORMS**. When applying for your certified copy of your driving record, please request Type 3A. If you do not receive paperwork from the court within 10 days of your request, please contact the court at 281-346-1796. Upon receipt of your request and payment, you will **then** have 90 days to:

Submit the DSC completion certificate (Court Copy) to the court signed by you along with your driving record. If you mail your Certificates, please contact the court to verify that your paperwork has been received and your case dismissed.
