## **FULSHEAR, TEXAS: 2015 EVENT RULES AND REGULATIONS**

**EVENT RULES AND REGULATIONS:** By submitting this "Booth Application," you hereafter are referred to as "Vendor."

### **SET UP AND BREAK DOWN**

Set up may begin 3 hours before event start and must be completed 30 minutes prior to event start. No unloading assistance is available. Each vendor will receive notice of their booth location and a site map upon check in on the day of the event. Booth break down must be completed by 12 midnight the evening of the event. Vendors are responsible to clean up their area thoroughly after the event.

### **INCLEMENT WEATHER**

This is a rain or shine event. No refunds will be issued. Fulshear Area Chamber of Commerce and the City of Fulshear, Texas will make every effort to notify attendees of inclement weather status during the event. However, it is each attendee's responsibility to act responsibly in order to protect their own safety and avoid harm.

### **RIGHT OF APPROVAL/CANCELLATION**

Fulshear Area Chamber of Commerce and the City of Fulshear, Texas reserves the right of approval of all items and the right to cancel a booth exhibit or require alteration or removal of any merchandise, product, or activity from the event which in our discretion is deemed detrimental to or inconsistent with the event. Fulshear Area Chamber of Commerce and the City of Fulshear, Texas will not be responsible for any vendor costs incurred due to this situation; no refund will be given.

### **WAIVER OF LIABILITY**

Fulshear Area Chamber of Commerce and the City of Fulshear, Texas and sponsoring organizations shall not be held liable to vendors for any damage, loss, or injury arising from any condition existing at the event, or any act, omission or negligence by another vendor, volunteer, visitor, or employee, any time before, during, or after the event.

### **SALES TAX**

Retail vendors are required to abide by state and local sales tax laws and the Fulshear Area Chamber of Commerce and the City of Fulshear, Texas are not responsible for the administration, collection, or remittance of sales tax for any vendors at the event.

### **PERMITS**

It is the responsibility of all exhibitors to obtain all permits and licenses required by local, county and state agencies. No food or beverage may be sold or distributed without approval and associated fees, permits and insurance requirements that apply.

### **INSURANCE**

Fulshear Area Chamber of Commerce requires all vendors and exhibitors to submit a certificate of insurance no less than 48 hours prior to event for the following vendors/exhibitors:

- All food and drink vendors
- Alcoholic drink vendors (general liability and liquor liability required)
- All amusement rides or conveyances
- All vendors/exhibitors who exhibit or utilize live animals of any type
- Vendors/ exhibitors displaying, exhibiting, demonstrating any mechanical and/or electrical products.
- All vendors providing the following: bounce houses, rock climbing walls or dunk tanks.

Fulshear Area Chamber of Commerce has the sole discretion to require evidence of insurance for any vendor or exhibitor as it deems necessary.

The Vendor hereby agrees to indemnify and hold Fulshear Area Chamber of Commerce and the City of Fulshear, Texas harmless for any and all claims and losses arising out of, or relating to a breach of this agreement.
